Culpeper Baptist Church Finance Committee Report September 25, 2024

Proposal:

The Finance Committee moves that \$250,000 be borrowed from the Endowment Fund current balance of \$ 346,631- Account 201 of the Balance Sheet and utilize this amount to reduce the existing mortgage. An Account Receivable should be established on the Balance Sheet to reflect the amount borrowed from the Endowment Fund. A rate of at least 3% should be established for this loan. Execution of this proposal will reduce the outstanding mortgage of \$1,145,498 by \$250,000, resulting in a balance of \$895,498.

Disccussion:

This move will reduce a current asset, the endowment fund, and replace it with an account receivable on the balance sheet. Effectively, the church is making a loan to itself.

Finance Committee

Culpeper Baptist Church Leadership Council Report September 25, 2024

- Our 250th anniversary year continues to be an exciting time as we welcome back former members and leaders to share in the history of our Church. The Leadership Council encourages you to become involved in as many aspects of our church's life as you can.
- We completed our training with GRACE, thank you for your participation.
- The Council has reached an agreement with the "Adult Day" Board of Directors on a three-year lease agreement for the space that they use. This agreement will be brought before the Church for approval prior to Trustee(s) signature.
- We continue to meet with CDC Board of Directors, as their current MOU for space use expires at the end of the calendar year. The Council is committed to supporting a vibrant and best practice approach to meeting the childcare needs of Culpeper. To support this vision, we are reviewing industry best practices and trends along with talking to other Churches that have established vibrant childcare ministries. We expect this effort to lead to a set of requirements that can be submitted to multiple industry partners.
- The Council is working to identify church members to fill upcoming vacancies on the various committees that serve our Church. We plan to have our recommendations ready for a church vote at our December business meeting.

Rebecca is developing choirs, both for the 2nd service and for the special 250th Anniversary Choir. She is also a skilled pianist and plays for the second service and periodically for first worship service as well. In addition, she is self-trained as an organist and practices frequently on the church organ.

Ministry Areas

Children – Maria coordinated our annual SPARK Camp that was held in July. It was our 4th year of Spark—which provides social and academic support to children and middle schoolers during the summer months. This age group also attended Passport Kids Camp at Eagle Eyrie in June—the first time in years! In addition, our old friends—The Charlottesville Ballet—held a dance camp for this age group.

Youth— Converge continues to have strong numbers, with Caleb and Danny leading! We are grateful for the volunteers (*but could use additional folks to help*) and part-time staff who make Converge happen each week. A group of 22 attended FUGE camp this summer, where the theme was the Revival Generation.

Child Protection Policy – GRACE training is finished. We are in the process of completing the policy and have met with youth and children's leaders to review the draft. Background checks are in process for folks who work with children/youth.

Young Adults – meet on Monday nights and average around 13. Chris is doing good work and is thinking about pivoting this group to younger folks.

Worship – The Anniversary Choir is off to a good start, although we do need more male participants. The choir will be singing once per month during the Fall.

Senior Adults – The Stronger Memory program is doing well. Generations Central has a group and so does Rappahannock Senior Center. Bible studies recently completed include I and II Thessalonians. We are currently studying Lamentations on Monday and Wednesday afternoons at the Culpeper and viewing Season IV of The Chosen on Tuesday mornings at the church. On Wednesdays for Everyone, we are studying Jonah.

Grief Groups – We currently have a group meeting at the county library that will conclude at the end of October. With the coming of the Thanksgiving and Christmas holidays, we will offer the annual 'Surviving the Holidays' workshop once in November and again just before Christmas.

Concerts

The Sanctus Real/Unspoken concert on Sunday, April 14, was a great success and the 3 summer concerts with up-and-coming artists were well attended as well.

The Culpeper Concert Series has garnered good-sized crowds, especially at the Patriotic Concert in July. Randy and Chuck are hometown favorites, and this concert was especially poignant this year because it was their 'farewell' concert. The Washington Balalaika Society Concert occurred just several days ago. We will host the Howard University Choir in mid-October and the Eric Byrd Trio will round out the concert schedule in early November.

250th Anniversary

We have had a great start to our 250th Anniversary Celebration! Our local newspapers and organizations have provided extensive publicity. We look forward to continuing to celebrate all year! Since our last business meeting, we have welcomed back Jimmy Durham, former Director of Music, Bert Browning, former pastor, and Dr. William Cale and his family (Dr. Cale is the son of Reverend Frank Cale, who pastored CBC from 1947-1957.). Our Anniversary Choir will sing at selected worship services through the fall, under the direction of Rebecca Schwier.

In mid-May, we hosted the Virginia Baptist Historical Society for their annual meeting with Dr. John Ragosta telling the story of religious liberty. Bert and Rose Browning also attended and hosted a Q and A period discussing the Sunday that President-elect and Mrs. Bill Clinton and Vice President-elect and Mrs. Al Gore attended CBC.

We celebrated with LifeSpire at The Culpeper during the summer with a churchwide picnic commemorating 75 years of operation as a continuing care community for senior adults. This was a wonderful opportunity for residents and staff of both entities to become better acquainted and to acquire perspective regarding our long, mutual commitment.

We have planned a Mission Sunday for November 3rd to celebrate God's work in Ukraine and Pakistan. Pastor Joel Rehmaf [Pakistan] and Pastor Vasyl Gustalo [Ukraine] will share their stories of God's work in difficult places during a breakfast meeting. Dr. Allen Jesse, of Highlands Fellowship, Abingdon, VA, will preach.

Staff Development

Lindsay, Christina, Danny, and Maria spent 2 days with the staff of Highlands Fellowship sharing with their worship and children's ministry teams.

Dan attended the church planting conference of GlocalNet in New Jersey, April 5-6. GlocalNet was founded by Dr. Bob Roberts.

Our staff continues to look for ways we can develop our skills through connecting with our church and community leaders.

Administration

Christina and Dan worked with Jerry Morris to develop a spreadsheet on use/cost of our facilities. The Leadership Council reviewed and discussed this in March, and we use this information to help our building partners understand the cost of the facilities and to make sure we are being the best stewards of our facility assets.
