### **Budget Narrative**

The Proposed 2025 Budget reflects an increase of \$102,000 in income. Based upon giving for the current year, tithes and offerings as well as mission giving have all increased and we have adjusted the 2025 Budget to reflect this fact.

#### Missions Budget:

We added Northstar Association to our Budget for the coming year. Northstar is an association of Baptist churches in northern Virginia. During the past two years, our staff has participated in multiple Northstar events. With that thought in mind, we propose to send Northstar \$2,500 in the 2025 budget.

In addition, we have included a contribution of \$12,250 for the Institute for Global Engagement (IGE). Bob Roberts serves as the president of IGE. This organization plays a vital

role in promoting religious freedom globally, which, in turn, has a significant impact on missions taking place around the world. Dan has been involved with IGE this past year, and we look forward to expanding this relationship in the future as we connect CBC's founding story of religious freedom to the needs of our world today.

#### Personnel budget:

Currently \$111,000 of the personnel allocation is for open positions (notably the Youth Director and Church Administrator positions). We hope to fill both positions in the coming year.

#### **Debt Retirement:**

Our monthly debt payment is \$12,586; \$151,032 annually, and we pay that sum through designated giving. We have budgeted \$200,000 for 2025 which is the same amount budgeted in 2024. This will allow us to make the monthly payment as well as additional payments to further reduce the debt. Designated giving in 2024 is behind where we need it to be.

#### **Finance Committee Action Item I:**

**a. Motion:** The Finance Committee of Culpeper Baptist Church moves the adoption of the Proposed 2025 Church Budget as written.

#### Action Item 2:

b. Motion: The Finance Committee moves that \$200,000 be borrowed from the current Endowment Fund balance of \$368,156, account 201 on the Balance Sheet, and utilize this amount to reduce the existing mortgage. An Account Receivable should be established on the Balance Sheet to reflect the amount borrowed from the endowment fund. A rate of at least 3% should be established for this loan. Execution of this proposal will reduce the outstanding mortgage of \$1,129,707 by \$200,000, resulting in an outstanding balance of \$929,707.

Our 250th anniversary year has been a tremendous success, and we look forward to working to set the stage for future growth and mission in our community as well as around the world in the coming year. Thank you to all the volunteers that made this year possible.

The Leadership Council is happy to announce that we have candidates for all of the church committee members whose term will expire December 31, 2024.

To support these efforts the Leadership Council, along with Dan, has worked hard to develop a strategy for financial lease arrangements between building partners and the church. Our vision is to provide long-term financial stability for our building, which is significantly larger than the immediate needs of the congregation. Toward that end, we have entered into a new lease agreement with Adult Day and are presenting an agreement for Playdate, a children's museum, for your approval.

Efforts are ongoing to establish a new agreement for a child development center, the current agreement expires at the end of the year, and we have received multiple offers to operate a center at the Church. An evaluation team is reviewing the offers and will make a recommendation to the Leadership Council before the end of the year.

# **Music Ministry**

<u>Youth Minister</u>: We continue our search for a Youth Minister. Frequent advertising through the Indeed online hiring site has produced little activity even with a \$5,000 increase to the compensation package from \$60,000 to \$65,000. Shortly after the first of the year, the job will be advertised through the Fellowship of Christian Athletes (FCA) network. The expense will be shared with FCA. If that effort is not successful, we will fund a search through a search firm dedicated to church related positions.

<u>Employee budgeting</u>: A 2025 3.5% merit increase budget has been proposed for our current workforce. One new position, Church Administrator/CEO has been proposed for hiring in the second half of the year. The job will be funded by lease income from our building partners. The incumbent will be responsible for all building maintenance and managing facilities for our building partners.

## **Ministry Areas**

<u>Children</u>: We have had a busy fall and activities in December are numerous as well. We hosted a Family Christmas Advent Breakfast early in the month with approximately 50 in attendance. The combined CDC and Unite Children's Choir is scheduled to sing mid-month and the annual kids Christmas party along with the Class with Clara [Charlottesville Ballet] will close out another busy year of ministry for them.

Youth & Young Adults: As of this writing, we still do not have a candidate in sight for the Youth Director/FCA representative. A trip to Liberty University to attend a Fall job fair at the end of October failed to yield a candidate. We will continue to pursue options. Converge continues to do well under the capable leadership of Danny Emery and Caleb Bish.

Chris Rogers continues to move the Young Adult group toward more communityoriented involvement by meeting at various venues around the Community and engaging with community leaders.

<u>Senior Adults</u>: Our senior adults have stayed busy all through the Fall with attendance at the Art of Aging Expo in October, Bible studies, monthly USDA food delivery, and working with Stronger Memory. In recent weeks, we have collected blankets and coats for hurricane victims. Just a few days ago, we celebrated Christmas together with a wonderful potluck lunch and games afterward.

<u>Grief Support</u>: Our regular grief support group will resume in February 2025 at the Culpeper Library. In the meantime, we have offered two two-hour workshops especially geared to coping with grief during the holidays. Both workshops were held here at the church and had good attendance.

<u>Concert Series</u>: Attendance has been outstanding for all of the concerts. In fact, we had over 300 at the Howard University Concert. Randy Sheets has been instrumental in this series through the years but is taking a step back in 2025. At the present time, we have 2 confirmed concerts for next year and are working on three others.

The Antioch/CBC Homecoming—the first time at the Davis Street Church since the Civil War—along with the Maranatha 23-year anniversary, were especially meaningful milestones for all of us. It was an absolute joy to welcome back former members and staff during the year, including Jojuan White, Mike Normoyle, Frances Laffoon, Fred Farrar, and many others.

Throughout the year, we participated in several community events, sharing our story of religious liberty. Roger Clatterbuck and I presented about the Davis Street Church at the Culpeper Museum of History, and in November, Andrew Gutowski and I had the honor of presenting about Elijah Craig at CMH as well.

Our Anniversary Sunday, November 17th, truly stood out as the highlight of our yearlong celebration! We gave our campus a fresh look, pressure washed the entrances and opened our doors wide to welcome a wonderful crowd of guests and longtime friends to celebrate this important day. This would mean a commitment of \$150 per month beginning January 2025. Habacuc and I plan to go in March of 2025 to "kickoff" the partnership and also to train with pastors.
